Freedom of Information Act 2000 – Request for Information

Thank you for submitting a request for information which we received on 5th October 2023 in relation to County Durham and Darlington NHS Foundation Trust (the Trust). Your request has been processed under the provisions of the Freedom of Information Act 2000 and I am now able to provide you with a response.

Your request was in relation to Dog Bite Related Admissions and I am providing the following information in response to your specific questions:

We would like to request the data gathered in the last 12 months from urgent care centres in the County Durham and Darlington NHS Foundation Trust. We are specifically interested in data relating to children aged 0 – 14 years.

We would like to know the following, which pertains to information/data that the CWILTED tool collects:

- **Where the incident occurred**
- **Type of dog**
- **Who the child was with at the time**
- **Whether the interaction with the dog was supervised/unsupervised**
- **The extent of injury**
- **Requirement to be seen by plastic surgery/maxillofacial teams**
- **Requirement for hospital admission**
- **Requirement for antibiotic treatment**
- **Follow up appointments**

The Trust does not centrally record this information and estimates that it would take a significant amount of time to gather the information requested. In order to gather this information it would require a member of staff to manually examine the sets of patient's notes for the entire community. Therefore, we are refusing this section of your request for information pursuant to section 12 of the Act on the grounds that we estimate that the cost of complying with the request would exceed the appropriate limit. The appropriate limit at the present time is £450.00 which equates to eighteen hours of work by a member of staff at the rate of £25 per hour.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log on the Trust's website. However please be assured that we anonymise all responses prior to adding them to the disclosure log.

I hope that this response has provided you with the information you had requested.
