Please note: From a revenue side of things, we are unable to accurately forecast as to what the spend is likely to be for the year as any current projections/forecasts which we complete are not done in the level of details requested, especially as some of these costs are Trust-wide costs rather than just within Health Informatics. Doing so would be extremely difficult, time consuming & potentially not accurate.

Staffing costs exclude costs relating to Information Governance, Health Informatics Business Management and Strategy and Delivery. These are not usually included in "in house IT staff".

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the County Durham and Darlington NHS Foundation Trust website.
