### **County Durham and Darlington NHS Foundation Trust replies:**

Under the Act enquirers have the right to anonymity, therefore we are unable to provide the information requested, to disclose this information would breach one of the data protection principles contained in the Data Protection Act 2018 in that it would render it possible to identify the individual. We do not believe that it would be fair to the enquirer for their identity to be made public. We therefore believe that the exemption contained within section 40 of the Act is engaged.

Therefore, a version of our response which will protect your anonymity will be posted on the County Durham and Darlington NHS Foundation Trust website.
