Please note, with regards to question 6: The Trust cannot provide a breakdown of the information requested as to do this would entail a manual trawl of all 14,325 attendances. The Trust does not record this data in a format that could easily provide the information requested, this would take over the permitted timescale within the Act therefore; we are refusing this section of your request for information pursuant to section 12 of the Act on the grounds that we estimate that the cost of complying with the request would exceed the appropriate limit. The appropriate limit at the present time is £450.00 which equates to eighteen hours of work by a member of staff at the rate of £25 per hour.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the County Durham and Darlington NHS Foundation Trust website.
