The Trust has issued the following number of doses to the eye units:

Ranibizumab (Lucentis):	508 vials
Bevacizumab(Avastin):	37 prefilled syringes
Aflibercept (Eyelea):	2253 vials
Fluocinolone:	0 implants
Dexamethasone:	11 implants
