Thank you for submitting a request for information which we received on 18 June 2020 in relation to County Durham and Darlington NHS Foundation Trust (the Trust). Your request has been processed under the provisions of the Freedom of Information Act 2000 and I am now able to provide you with a response.

Your request was in relation to Audited accounts and a number of other issues concerned with private hospitals and procedures and I am providing the following information in response to your specific questions:

1. A copy of the audited accounts for year end 2019-20?

The published accounts for 2019-2020 will form part of the annual report and will be made available on our website, or by request to the Foundation Trust Office, Executive Corridor Darlington Memorial Hospital, Hollyhurst Road, Darlington, DL3 6HX from the date of uploading/ publication. This is expected to be around mid-July 2020.

2. Names of all private hospitals in Darlington?

The Trust is unable to comment on health care providers outside of the Trust.

3. The hospital fees for a male circumcision operation and name of urologist surgeons and outpatient fees?

The Urology service at the Trust is operated by neighbouring Trusts not County Durham and Darlington NHS Foundation Trust (CDDFT).
