Thank you for submitting a request for information which we received on 10 November 2020 in relation to County Durham and Darlington NHS Foundation Trust (the Trust). Your request has been processed under the provisions of the Freedom of Information Act 2000 and I am now able to provide you with a response.

Your request was in relation to health visiting teams and I am providing the following information in response to your specific questions:

#### **Regarding the clinical staff in your health visiting teams for Darlington Council, on 1 February of 2016:**

- 1. How many full time equivalent (FTE) clinical staff coded as health visitors were employed in your health visiting teams? Please provide this information broken down by NHS pay band?**
- 2. How many FTE clinical staff coded as health visitors with caseloads, were employed in your health visiting teams? Please provide this information broken down by NHS pay band.**
- 3. How many FTE clinical staff who are NOT coded as health visitors were employed in your health visiting teams? Please provide this information broken down by NHS pay band.**
- 4. How many FTE clinical staff (who are NOT coded as health visitors) with caseload were employed in your health visiting teams? Please provide this information broken down by NHS pay band.**
- 5. How many children under-5 years of age were your health visiting teams for Darlington responsible for? (Also on 1st February of 2016)
