Freedom of Information Act 2000 – Request for Information

Thank you for submitting a request for information which we received on 10th January 2022 in relation to County Durham and Darlington NHS Foundation Trust (the Trust). Your request has been processed under the provisions of the Freedom of Information Act 2000 and I am now able to provide you with a response.

Your request was in relation to Covid data and I am providing the following information in response to your specific questions:

Date range 1st January 2021 - 31st December 2021

The amount of people admitted to County Durham and Darlington NHS Trust hospitals for covid, most importantly their vaccine status when admitted (1, 2, 3 shots, unvaccinated)

Please see the table overleaf and note that patients are swabbed and screened for Covid-19 on admission and it is the results of these tests which determine whether or not they have Covid-19 and if positive they are coded as such. However this is not indicative of the reason they have been admitted, for example they could be admitted with a broken leg and also test positive for Covid-19 but that would be an incidental finding rather than the reason for admission.

As such please note that the data in the table does not reflect the number of patients admitted due to Covid-19 only the number of patients admitted who had Covid-19 at the point of admission.
